1. REGULAR MEETING

In addition, students find it difficult to get some of the information they need sent to colleges because transcripts can't be sent online and must be printed out. It can take up to a week to get transcripts printed.

5.3 Legislative Update

Chris Hambuch-Boyle shared information from WASB about general school aid certified to districts. Data showed that 220 of the state's public schools received more aid than last year, 202 districts had a decrease in aid, and 19 districts received no state equalization aid. Eau Claire had one of the largest decreases in the state. WASB members oppose the use of federal and state tax monies to subsidize nonpublic schools through a voucher system. Since 2004 about \$139 million of taxpayers' money was paid to failed voucher schools.

9. WORK SESSION

Dr. Hardebeck shared information from Victoria Berhnardt as a guideline for the Board to think about how it might better understand and assess the needs of the whole child. A whole child approach to education is defined by policies, practices and relationships that ensure each child is healthy, safe, engaged, supported and challenged. Various research studies show that characteristics that are conducive to successful adults include work ethic, focus, ability to work with others, flexibility, ability to deal with conflict and accountability. Dr. Hardebeck reviewed predictors/indicators of post-secondary success and how that will address the Key Works of alignment, assessment and accountability. Any definition of multiple measures should include student learning, demographics, perceptions, and school processes. She shared examples of each and how looking at these measures intersected helps to begin to predict if the actions, processes and programs that are being established will meet the needs of all students. She noted that just looking at student achievement measures focuses teachers only on the results. It does not give them information about what they need to do to get different results.

The Board discussed this information and asked clarifying questions. The Board talked about ways to systematically measure behavioral predictors of post-secondary success like perseverance and work ethic. Dr. Hardebeck said that intentional teacher observations can help greatly in this area. She added that teachers are trained in culturally responsive practices and the District has spent some time trying to teach those strategies.
