## SPECIAL MEETING COVID-19 Discussion

A plan to close schools after 5:00pm on Wednesday, March 18, 2020 and cancel all before and after school activities and field trips as of 6:00am on Saturday, March 14, 2020 was reviewed. The plan included ways to support student learning during the closure, provide meals to students who need it, get student medication home, and keep staff supported and at work. It was stated multiple times that the situation is changing rapidly, and the plan will be reviewed and modified as the situation changes. The State has indicated a possible reopening of schools on Monday, April 6, 2020. That date may change as well as the situation changes.

Board members discussed and asked questions.

Mark Goings questioned if the situation would warrant another special meeting as changes are needed in the coming days.

The Board stated the Superintendent has the authority to make decisions related to the closure and staffing, but she has consistently gathered input from the Board as well as updated and utilized the District's Pandemic Plan. The Board and Superintendent will continue to adapt and communicate quickly as changes are needed.
