Eau Claire Area School District Library Plan for 2024-2027

James Martin, Director of Technology, and Caroline Akervik, Library Media Coordinator, presented the updated Eau Claire Area School District Library Plan for 2024-2027, emphasizing the vision and role of libraries in promoting reading, digital citizenship, and 21st-century skills. They highlighted the importance of libraries as inclusive and collaborative learning spaces that allow student to pursue interests. The Common School Fund is the primary source of funding for many library resources. Library Media Specialists (Mary MacLeod from Prairie Ridge, Lauren Zygowicz from Lakeshore and Robbins, and Becky Wojahn from Memorial) shared various activities and the diverse resources available in the district's libraries. Additionally, both high school libraries will be remodeled in summer 2025, using remaining referendum money. Discussion and questions followed. No action was taken.

MONITORING DISTRICT RESULTS

Dr. Mark Elworthy, Executive Director of Business Services, and his staff presented the monitoring report for OE-3 Climate Commitment. Jeff Nestor, Facilities General Manager, shared past, current, and future projects including HVAC upgrades, solar panels, low maintenance flooring, and energy-efficient building improvements, all of which have reduced energy consumption and waste. Staff members and a student shared their successful composting program at Locust Lane. They emphasized the importance of student involvement and the positive impact on the environment. Future District projects include implementing composting at the middle schools and high schools, as well as planting new trees, including native species. Discussion and questions followed.
