# Legislative Liaison Report

Commissioner Dement provided a Legislative update, which included the following:

- The Department of Administration announced that Wisconsin has a \$4.6 billion surplus and 121 school districts in WI went to referendum. On November 5, the ECASD operational referendum passed with 64% of the vote; almost 80% of state educational referendums passed.
- State Superintendent, Dr. Jill Underly, submitted a biennial budget request which includes \$4 billion for investments in K-12 public education.
- Governor Evers and DWD announced \$1 million in grant funding for teacher training and recruitment.
