1. Davey IZ Proposal Update: Board Presentation July 18, 2016

Tim Leibham reported Bill Giese and the Sam Davey team did a great job presenting their IZ Proposal to the Board of Education (BOE) on July 18. The Parent Survey shared at the same board meeting reflected parents want more challenging and rigorous school programming. The previous Student Survey showed students seek more relevance of classroom instruction. This validates what the LEAP committee is doing! The BOE will give final approval on August 1, 2016.

2. Committee Policy and Membership Structure

Board Policy 332, Charter/Choice Programming Committee, will be revised with the committee's new name, Learning Environments and Partnerships (LEAP). The group compared current committee membership with what is stated in Policy 332 to determine if additional members are needed. This policy also states the Executive Director of Administration will serve as the liaison, which is inconsistent with recently revised Board Policy 185, Board Committees that states, "This Committee shall include two Board members and others as determined by the Board of Education, the Committee and the Superintendent." Chris Hambuch Boyle will clarify this at the next Policy and Governance committee meeting and will suggest pulling the committee structure out of the policy and establishing a rule.

The committee discussed the purpose and structure of the committee noting that as more proposals are submitted, the need for an Ad-Hoc committee to review the first two steps would be beneficial. At least one member of the core committee should serve on

any Ad-Hoc committee. It was recommended to have two non-charter principals serve on the committee. The core committee will determine if a proposal will proceed to the BOE.
