Tim provided a chart that showed the 22 Year Comparison of District September Pupil Count and where the trends were that could have fluctuated based on birthrates, economics, etc. A PowerPoint presentation was shown based on information acquired from the 2010 Census Data APL source that shows a 5 year trend on enrollment statistics broken down by multiple factors. This information is used to determine growth in in our schools and outlying areas for future planning.

Dan presented to the group information about referendum basics, long term debt, notes and bonds. He also walked the Committee through the timeline of how long it takes to prepare and work towards a successful referendum if the district were to ever go that route.
