Referendum Committee Report (GC-5)

Commissioner Johnson provided a Referendum Committee report. The committee met on March 11 to solidify final questions that will be on the community survey.

Legislative Liaison

Commissioner Farrar provided a Legislative update, which included the following: The state Legislature's Joint Committee on Finance (JFC) voted to approve 4 of the 11 proposed curricula for early literacy. The Senate Committee on Mental Health, Substance Abuse Prevention. Children and Families voted against legislation that would bar transgender athletes from playing girls sports. Voters will find 91 local school district referendums on the April 2 ballot in 85 districts. With new state legislative maps getting signed into law, lawmakers across the state are turning their eyes to the coming election season. New maps bring many changes, including possible changes to longstanding relationships built with state representatives. Public education partners have created a short, animated video that explains public school funding.

Key Communicators Group Update

Commissioner Dement provided an update on the Key Communicators Group, which recently met. The group focused on OE-3 Climate Commitment and OE-10 Financial Administration. Participants were pleased to hear that the District is on track with climate commitment goals. The majority of the conversation centered on the underfunding of education in Wisconsin, as well as the fiscal cliff caused by the expiring of ESSER funds and the necessity of a referendum.

BOARD DEVELOPMENT

President Nordin reconvened the meeting at 7:19 p.m. Abby Johnson, Executive Director of Business Services, presented information to the Board regarding the upcoming operational referendum. The goals for this session included sharing current budget projections, finalizing the community survey, determining what amounts to test in the survey, and reviewing what recurring vs. non-recurring entails. A timeline and target dates were shown (the survey will need to be finalized by March 29; phone interviews will begin on April 2; survey results will be presented on May 6; the School Board will adopt a question on June 3). Budget projections with various referendum amounts, along with the tax impact, were displayed. An indepth look at the survey took place, which included the survey introduction, demographics, specific questions, and what amounts to include. Examples of recurring vs. non-recurring questions were provided, as well as the District's referendum history. Discussion and questions occurred throughout the session.
