### Referendum Committee Report (GC-5)

No Referendum Committee Report, as Commissioner Johnson was absent. The Committee has not met since the last Board meeting.

### **Legislative Liaison**

Commissioner Farrar provided a Legislative update, which included the following:

- Voters across Wisconsin approved 62 of the 103 school district referenda placed on primary and general election ballots this spring. The 60.2% approval rate was the lowest in a midterm or presidential election year since 2010. More districts asked to increase property taxes for operations rather than capital needs, a sign of the stress they are facing from inflation, state caps on their revenues, declining enrollment, and the expiration of federal pandemic aid.
- Governor Evers signed a bill requiring Hmong and Asian American instruction in K-12 schools.
- Governor Evers vetoed AB 377, a bill to regulate the participation of transgender athletes in school sports.

### **FOCUS ON RESULTS**

Jim Schmitt, Eau Claire Virtual School (ECVS) Principal, and Shannyn Pinkert, ECVS Governance Board, Inc., President, presented information about ECVS. ECVS is a community-based and relationship-based K-12 school, governed by a local board. The number of enrolled students and the services offered at each grade level were provided. Local and personalized connections to the Eau Claire Area School District and staff, along with regular communication between ECVS and schools, are keys to the success of the school and its students, with many layers of support offered. ECVS partners with Pearson for their online curriculum and has options for in-person classes and activities, depending on the student's grade. Additional details shared included successes of the program, opportunities for growth, demographics, reasons for enrolling in ECVS, credit attainment rates, 4-year graduation rates, graduate post-secondary enrollment, and family survey results.
