- Secretary of State Sarah Godlewski announced a historic \$70 million distribution from the Common School Fund to Wisconsin public schools. It is the sole source of financial support for books, technology, and other essential learning tools for more than 90 percent of Wisconsin's public school libraries.
- The membership of the 2025-26 Joint Finance Committee is set, with leadership in both chambers and parties announcing their picks. If no unexpected changes occur, the committee will see five new members, including four Republicans. Together they will help write the state budget and wield significant power to craft policy and oversee financial appropriations of the state for the coming two years.
