## Meeting was called to order at 7:03pm

- I. Superintendent Report.
  - a. Excited about the work being done towards the approved referendum.
  - b. DPI report card is done, needs final approval before disbursal.
  - c. Lull for Finance before prep for 24-25 begins; Board workshop in December.
- II. Attendance 101.
  - a. Pre-pandemic most schools in the green (meaning above 95% attendance rate for the year).
  - b. Post Covid, ECASD has struggled getting schools back in the green.
  - c. High level overview of attendance rate at each school/overall for school level; shared procedures and policies by school level.
  - d. Principal Oldenberg spoke to the difficulties overcoming habitual absences.
    - . Different circumstances around absences (care taking of younger children, working to help family).
    - ii. Excused absence work can be made up, unexcused cannot.
    - iii. SOAR pilot program (6 teachers) assigns a score that separates behavior from academics, coach students on soft skills, habits of effective students and lifelong learners.
    - iv. Middle and High School have program accountability.
    - v. Attendance determines whether you can participate in sports, band, etc.
  - e. Principal Stordahl addressed elementary school.
    - i. (K-3 learning to read, 3-5 reading to learn).
    - ii. Small change in verbiage: "Nice to see you" vs. "Where were you" helps alleviate fear of returning.
    - iii. Tardies have a lesser impact due to morning meetings.
  - f. Seeking breakdown of the absences (examples: excused absences a % were due to appointments, illness or vacation or unexcused absences a % were skipping, no call in, circumstances).





- III. Different policies and procedures from early education to secondary level education.
  - a. Elementary checks attendance 2x per day (early morning and early afternoon); HS checks every period.
  - b. Absence % is both excused and unexcused.
- IV. Follow up items.
  - a. Skyward notification timing.
    - i. A concern to families for differing reasons (shared parenting, unnecessary for some students).
      - 1. Can this be changed for notification preference and timing?
    - ii. Attendance refresher.
      - Can we send a District email to educate? Parents call to report absence, time consuming for admin staff. Suggested that emailing the school or utilizing the Skyward website/app to report your absence.
    - iii. Can busing times/tracking be implemented? Notifications for a bus running late?
